AUTO PAY RULES AND POLICIES

- Auto Pay transactions will be processed for team gymnasts: on the last business day of each month for the upcoming month's charges. For recreational students: on the last Friday before the end of early payment week for the upcoming terms charges.
- If Desert Gymcats is unable to obtain authorization, you will no longer qualify for the Auto Pay discount.
- By enrolling in the Auto Pay program, you authorize Desert Gymcats to automatically bill your credit card on file for all charges billed to your account each month. Charges that may be billed on your account may include, but are not limited to: Monthly tuition, Term tuition, Annual Registration, Open Gym and Parents' Night Out; Flip Flop Shop, Meet Fees; Coaching Fees and Pro Shop/ Uniform purchases.
- It is the customer's responsibility to provide all updated information in advance of the payment due date with any credit card information changes(i.e. Credit card number, billing address, expiration date, etc.) to avoid declined transactions and associated fees.
- Statements will NOT be sent out prior to billing your credit card. If you have questions about a charge, please contact us via email, telephone or in person and we will be happy to provide the details of your account balance.
- Auto Pay can be terminated at any time. Recreational Students: Notice must be received prior to the beginning of the new term in order to avoid being charged for the new term. Competitive Gymnasts, Dance Team and DCX Members: notice must be received by the 25th of the month to avoid being charged for the upcoming month (For example: You must submit your cancellation notice by Aug. 25th to avoid charges on September 1st, etc.)
- Notice MUST BE in WRITING via one of the following methods: Email, Fax or delivered in person.
- Desert Gymcats will not issue a refund for any charges if notice was not received in the time outlined above.
- Desert Gymcats reserves the right to cancel your enrollment in the Auto Pay and/ or discontinue the Auto Pay program at any time

Authorization

I authorize Desert Gymcats to charge the above listed credit card each month for my total account balance. If Desert Gymcats is unable to obtain an authorization, I understand that I will no longer qualify for the Auto Pay discount and the full amount will be billed to my account. I agree to provide updated information pertaining to my card in order for an authorization to be obtained. I understand that I may terminate this agreement by : Recreational students: giving written notice before a new term begins; Competitive gymnasts; dancers and DCX team members: no later than the 25th of the month.
